Executive Summary

In 1967, the Hawaii State Legislature created the Crime Victim Compensation Commission (the "Commission") to mitigate the financial impact suffered by victims of violent crime. The Commission disburses funds to pay un-reimbursed expenses for crime-related losses experienced by victims who suffer physical or emotional injury, or death, as the result of a violent crime. During Fiscal Year ("FY") 2005, the Commission processed over 1,270 applications, including 880 new applications.

The Commission continues to pursue its mission to provide each claimant with compassionate and timely service. The Commission actively collaborates with numerous public and private agencies dedicated to serving crime victims as part of its effort to continuously improve the delivery of victim compensation services.

Current Commission projects include the Mass Violence and Terrorism Response Project (the "Response Project"), the Restitution Recovery Project (the "Restitution Project"), and the National Association of Victims of Crime Act Assistance Administrators Strategic Planning Project (the "Strategic Planning Project").

The Response Project integrates compensation and victim services into the mass violence and terrorism response protocols of the County and State Incident Command Response model. The Response Project also facilitates Commission coordination with the members of the Hawaii Volunteer Organizations Active in Disaster ("VOAD") to support a more effective response strategy and to reduce duplication of services for victims of mass violence and terrorism. The Response Project will enable the Commission and the County Victim Assistance Programs to cooperatively provide seamless and timely services to victims and survivors of, and witnesses to, mass violence and terrorism.

The Restitution Project collects restitution payments from inmates and parolees and disburses those funds to the crime victims. As a result of the Restitution Project, many more crime victims will receive reimbursement from offenders for their crime-related expenses. These increased payments will hold the offender accountable for the financial losses inflicted upon the victim of their crime and they will begin to develop a sense of self-respect and pride in righting the wrongs they have committed.

The objective of the Strategic Planning Project is to enhance the delivery of victim services to four underserved crime victim populations: elderly persons; immigrants or persons with limited language proficiency; persons with disabilities; and visitors to Hawaii. The Commission is working in collaboration with other government agencies and various community partners to develop a Strategic Plan that will address the needs of these underserved crime victim populations. The University of Hawaii Public Policy Center will publish the Strategic Plan in October of 2005.


The recent Justice Department Office for Victims of Crime audit (the "Audit") noted that the Commission had initiated or participated in a number of projects that positively impacted the services provided to crime victims in Hawaii. These projects include both the Response Project

and the Restitution Project. The Audit Report also noted that the draft polices and procedures manual developed by the Commission "...is worthy of recognition as it appears extremely thorough and, once finalized, may serve as a model for other state compensation programs...."

Achieving, and maintaining, a consistent and adequate source of non-tax revenue to underwrite the costs of compensating crime victims, and to pay operating expenses, remains the most important issue facing the Commission. The Commission has not received any general funds from the State for several budget cycles, and now relies solely on non-tax revenue and matching federal funds. The primary source of non-tax revenue for the Commission is the mandatory crime victim compensation fee (the "Compensation Fee"). In 1998, the Legislature established the Compensation Fee and directed that it be assessed against all criminal offenders by the Judiciary to provide a reliable funding base to support the Commission's mission to help restore crime victims who suffer from financial and emotional loss.

The Commission estimates that there has been a shortfall of over one million dollars (\$1,000,000.00) in revenue collections (the "Revenue Collection Shortfall") since the Compensation Fee was enacted by the Legislature. Despite the Legislative mandate, some judges are still not assessing the Compensation Fee in all eligible cases. Ongoing court monitoring surveys conducted by the Commission indicate some improvement in the assessment and collection of the Compensation Fee. However, there remain a significant number of cases where judges are not requiring the offenders to comply with this Legislative mandate. In many of the cases surveyed, the judge does not explain why the Compensation Fee was not assessed. The impact of the Revenue Collection Shortfall since the Compensation Fee was enacted is to deprive the Commission of its ability to ensure adequate compensation to victims of violent crime in Hawaii.

To address and diminish the Revenue Collection Shortfall, the Commission was forced to seek an increase in the amount of the Compensation Fee by ten dollars (\$10) during the 2005 legislative session. Act 144 of 2005 increased the Compensation Fee by five dollars (\$5) in all categories. The Commission will continue to monitor the incidence of the assessment and collection of the Compensation Fee by the Judiciary. Dedicating resources to court monitoring is necessary to ensure that there is sufficient funding to provide adequate compensation to violent crime victims in Hawaii, and to ensure the continuing fiscal self-sufficiency of the Commission.



Mission Statement

"The mission of the Crime Victim Compensation Commission is to equitably and efficiently provide crime victims the services due to them under Hawaii law. In doing so, the Commission treats every victim and survivor with dignity and respect, acknowledging the tremendous impact that violent crime has upon our society."

Overview and History

The Hawaii State Legislature created the Commission in 1967, making it the third agency of its kind in the nation. Hawaii's program was established to pay un-reimbursed expenses to victims who suffer physical or emotional injury, or death, as the result of a violent crime. Hawaii also recognizes the need to acknowledge the pain and suffering of crime victims. The Commission provides the State with an effective and fiscally efficient vehicle through which to acknowledge victims of violent crimes.

Between 1967 and 2002, the primary source of funding was State general funds appropriated through the Legislature. Beginning in FY 2003, no State Hawaii taxpayer funds are expended to operate the Commission. Commission non-tax funding is achieved through the following means:

- Compensation Fees assessed by judges against convicted offenders
- Court-ordered restitution paid by offenders to reimburse the Commission for compensation previously paid to victims
- 10% of all Hawaii inmate wages regardless of where the inmate is housed
- Interest income from funds on deposit
- Federal funds secured through the Victim of Crimes Act ("VOCA") the Commission receives a sixty percent (60%) match from VOCA for every State dollar expended to compensate victims of violent crime

Since its creation, the Commission has processed approximately 17,000 applications for compensation from people in Hawaii who have been victims of violent crimes. Currently, the Commission receives about 1,000 applications, and awards approximately one million dollars (\$1,000,000), annually. Awards assist the victims with medical costs, lost wages, funeral expenses, and counseling costs that are not covered by any other source.

In order for a victim to be eligible for compensation, the incident must be reported to law enforcement within 72 hours, and the Commission must receive the application for compensation

within eighteen (18) months, of the date of the incident. The applicant must provide the Commission with documentation such as medical bills, insurance statements, pay stubs, and/or income tax returns in order to substantiate the claim for compensation.

Annual Activity

Operations

During FY 2005, the Commission received 880 new applications for compensation and processed 1,270 new and ongoing applications. The Commission gives each application full consideration and works diligently with every applicant to ensure accurate and efficient claims processing.

FY 2003 is the first year that the Commission has operated without expending any Hawaii

taxpayer dollars. This means that all funds come from the non-tax sources listed above in this Report. It is, therefore, essential that the Compensation Fee be assessed and collected by the Judiciary from all appropriate sources. The Commission relies on cooperation from the Judiciary to assess and collect the Compensation Fee from convicted offenders in all eligible cases.

It is vitally important to note that Hawaii now receives a sixty percent (60%) federal match from VOCA. Therefore, every dollar of Compensation Fees not assessed by judges against, and collected from, all eligible convicted offenders is a compounded loss due to the concomitant loss of the sixty percent federal match.

Commission Projects

Mass Violence and Terrorism Response Project

In 1999, an employee of a national copier company murdered six co-workers in Honolulu. In the aftermath of this tragedy, the Commission identified two primary constraints that limited its ability to assist survivors of incidents of mass violence and terrorism. First, the Commission did not have the statutory authority to provide compensation for mental health counseling to surviving family members, witnesses, or individuals who worked or were schooled at the scene of this type of incident. Second, compensation and victim services were not integrated into the County and State Incident Command Model for

responding to mass violence and terrorism. Third, compensation and victim services efforts were not coordinated with the members of the Hawaii Volunteer Organizations Active in Disaster ("VOAD"). These constraints limited the ability of the Commission and the Victim Witness Programs to respond to the immediate needs of victims and survivors of, and witnesses to, these types of mass casualty events.

The first constraint was addressed when the Commission lobbied for legislation to authorize the disbursement of compensation to fund mental health counseling services for surviving family members, witnesses, and individuals who worked or were schooled at the scene of an incident of mass violence or terrorism. In 2000, the Legislature passed a bill authorizing the Commission to provide compensation for mental health counseling services to the victims and survivors of, and witnesses to, mass violence and terrorism incidents.

The second constraint was addressed when the Commission and representatives from various Federal, State, and County law enforcement agencies began a series of meetings to develop a strategy to eliminate this constraint. Meetings in each of the Counties brought together

The September 11, 2001 terrorist attacks has a profound effect on the victim service community – one that forced providers to look at terrorism, and their response to it, in new ways. The unprecedented level of victim need overwhelmed established emergency response plans and protocols. State compensation programs struggled to determine who was eligible for payments and to process claims, and few service providers felt adequately prepared to deal with the number of people afflicted by grief and posttraumatic stress disorder.

County and State incident command response agencies, the United States Attorney, the State Department of the Attorney General, the County Victim Witness Programs, and the Commission to discuss the integration of compensation and victim services into the command response model. Meeting participants recognized that the incident command agencies had already developed protocols for dealing with mass violence and terrorism. Everyone agreed that the most effective strategy would be to build the compensation and victim assistance protocol around the existing command response protocol.

The third constraint is being addressed through increasing the Commission's involvement with VOAD. The mission of VOAD is to coordinate the efforts of its members in responding to disasters, so

that survivors receive timely and appropriate assistance in a manner that maximizes resources and limits duplication of services. VOAD members coordinate, plan, and practice responding to disasters. Members include, among others: the American Red Cross; Aloha United Way/211; FEMA; Habitat Hawaii; Helping Hands Hawaii; the Salvation Army; and representatives from the faith-based community.

The Commission further increased its ability to respond to the needs of mass violence and terrorism survivors by creating new links on the Commission's web page that enable survivors to access information in thirteen (13) different languages about how to help parents and children deal with trauma. The Commission and the Hawaii Information Consortium, which administers the State web page, also developed a protocol to distribute real-time information through the Commission's web page to survivors and the public about where to seek assistance in the event of an incident of mass violence or terrorism.

The Commission and other stakeholders continue their collaborative efforts to ensure that the needs of victims, survivors, and witnesses will be met seamlessly in the event of another incident of mass violence or terrorism in Hawaii.



Restitution Recovery Project

"...in the criminal justice system, the victim of crime is almost always neglected. By requiring the convicted person to make restitution and reparation to the victim, justice is served. In so doing, the criminal repays not only "society" but the persons injured in the criminal's act. There is a dual benefit to this concept: the victim is repaid for his loss and the criminal may develop a degree of self-respect and pride in knowing that he or she righted the wrong committed."

Sen. Stand. Comm. Rep. No 789, in 1975 Senate Journal @1132, commentary on the Senate's intent in passing HRS section 706-605(1)(e) which authorizes Courts to order restitution.

In 1975, Section 706-605(1)(e), Hawaii Revised Statutes, was enacted to provide the Courts with specific statutory authority to order defendants to make restitution payments to cover the economic losses suffered by the victims of their crime. Since the passage of this provision, a significant number of victims have not received the court-ordered restitution that they are entitled to. Victims have found it particularly difficult to recover court-ordered restitution from sentenced felons¹ and parolees.

The Judiciary previously processed restitution payments for all offenders, including inmates and parolees. For the last decade, the Judiciary has tried to divest itself of the responsibility for processing restitution payments made by inmates and parolees. During this time period, the Judiciary and PSD have been at an administrative stalemate over who has the responsibility to process restitution payments made by inmates and parolees.

The system that was created to process court-ordered restitution payments was not working. In order to open a restitution account for an inmate or parolee, the Judiciary required the name and address of the victim before they would accept any restitution payments. This procedure created a significant barrier to the payment of restitution by inmates and parolees. In many cases it was difficult or impossible for PSD and the Hawaii Paroling Authority (the "Paroling Authority") to secure the name and address of the victim. Victim service providers were understandably uncomfortable about giving the names and addresses of domestic abuse, sexual assault, and other crime victims to PSD and the Paroling Authority. They were concerned that victim safety would be jeopardized if an inmate or parolee inadvertently saw the name and address of their victim in their file.

Despite numerous meetings between the Judiciary, PSD, the Paroling Authority, and victim service providers, and several false starts, efforts to resolve this issue ultimately failed until the Commission stepped forward. With the support of the PSD Director, the Paroling Authority, and

the Honolulu Victim Witness Kokua Program, the Commission initiated a pilot project to accept responsibility for the collection and disbursement of restitution paid by inmates and parolees.

The Restitution Project

On January 1, 2003, the Commission initiated the pilot Restitution Project to collect and disburse restitution paid by inmates and parolees. The Commission has opened over 990 restitution cases

and collected over \$268,000 in restitution to disburse to crime victims from January 1, 2003 through November 30, 2005. Information identifying the whereabouts of crime victims is kept confidential so that the safety needs of victims are being met. The barriers that made it difficult for PSD and the Paroling Authority to

open restitution accounts at the Judiciary have also been eliminated. PSD and the Paroling Authority need only send restitution payments to the Commission. The Commission and its partners, the County Victim Witness Programs, locate the crime victim, and the Commission disburses the restitution payment to the victim.


PSD and the Judiciary have a significant number of long-standing restitution cases where they received restitution payments but were unable to locate the victims. The Commission and the County Victim Witness Programs have committed to assist PSD and the Judiciary in resolving these cases by helping them locate the crime victims. This will benefit the victims and enable PSD and the Judiciary to dispose of these unresolved cases.

A functional restitution project benefits all involved. It is now easy for Parole Officers to increase the accountability of their clients by having them repay the crime victim they injured. This project also assists the County Victim Witness Programs in their efforts to restore the crime victims they serve. some cases where the Commission provided awards to crime victims for medical, mental health, or funeral costs, the Commission is reimbursed those funds, allowing more crime victims to be helped.

"Restitution is the cornerstone of restorative justice. Saying we are committed to restorative justice means nothing unless we make a sincere and concerted effort to make sure victims get restitution – without that -restorative justice means nothing. Restitution collection from inmates and parolees has increased significantly over the tenure of the project. In the first year of the project the Commission collected more than \$52,000 and in the third year, the Commission collected more than \$128,000.



Restitution payments are from inmates and parolees and does not include payments from inmates incarcerated as a condition of probation.

The Commission is committed to the Restitution Project going forward as it has been a win-win situation for crime victims and all of the agencies involved in the effort.

National Association of VOCA (Victims of Crime Act) Assistance Administrators Strategic Planning Project

Hawaii is one of six states participating in the National Association of Victims of Crime Act Assistance Administrators Strategic Planning Project (the "Strategic Planning Project")². The Commission has collaborated with various Federal and State agencies and community partners in conducting meetings where the Strategic Plan has been developed. Meeting participants have identified underserved victim populations and set performance goals directed towards meeting the needs of those populations.

The Strategic Planning Project is well underway with stakeholders and community partners having met in focus groups in all four counties, and on six islands, statewide. Focus group participants have worked to identify the needs, gaps in services, systemic issues, and solutions to problems in providing services to underserved crime victim populations. Elderly persons, immigrants or persons with limited language proficiency, persons with disabilities, and visitors to Hawaii are the four underserved victim populations that are the focus for meeting participants.

The Strategic Planning Steering Committee provided policy direction and oversight of the development of the Statewide Strategic Plan for Victim Services (the "SSPVS"). The Committee members include: Mei Chun, Victim-Witness Coordinator, U.S. Attorney's Office, District of Hawaii; Pamela Ferguson-Brey, Executive Director, Crime Victim Compensation Commission; Momi Kamau, Chief, Maternal Child Health Branch, Hawaii State Department of Health; Lena Lorenzo, Director, Victim-Witness Assistance Division, Department of the Prosecuting Attorney, County of Maui; Henry Oliva, Deputy Director, State Department of Human Services; and Nancy Ralston, Criminal Justice Planning Specialist, Crime Prevention and Justice Assistance Division, Department of the Attorney General.

Focus group questions were constructed around four broad themes: 1) What resources are available in the communities?; 2) What should be the key features of the Strategic Plan?; 3) What are the strengths and weaknesses of the draft Plan?; and 4) What needs to be improved in the delivery of services?

Meeting participants were invited because of their knowledge, interest, and involvement with the four identified crime victim populations. The elderly victim focus groups included individuals from the Legal Aid Society of Hawaii, Adult Protective Services, adult day care centers, public health nurses, Medicaid, volunteers, advocacy/assistance groups, and state and county governments. The immigrant victim focus groups included domestic violence assistance centers, homeless shelters, faith-based groups, immigrants associations, service providers, volunteers, advocacy/assistance groups, and state and county governments. The disabled victim focus groups included individuals representing disabilities rights groups, homeless shelters, sex abuse treatment centers, vocational rehabilitation centers, advocacy/assistance groups, and state and county governments. The visitor victim focus groups included individuals representing the visitor industry, visitor bureaus, law enforcement, criminal justice, service providers, volunteers, advocacy/assistance groups, and state and county governments.

THE STRATEGIC PLAN VISION

The vision of the SSPVS is to provide a seamless service delivery system that is victim centered and inclusive.

Elderly Crime Victims

The goals for elderly crime victims are: 1) to reduce and prevent consumer fraud against the elderly, and provide services to elderly victims of fraud; 2) review existing laws and propose legislation to strengthen and enhance the ability of law enforcement agencies to investigate and prosecute perpetrators of elder abuse and neglect; and 3) increase successful prosecution of perpetrators of crimes against the elderly.

Immigrant or Crime Victims with Limited English Language Proficiency

The goals for immigrant or crime victims with limited English language proficiency are: 1) to provide immigrant victims with meaningful and comprehensive access to victim assistance services; 2) to establish Hawaii as a model for the nation in creating and maintaining a biasfree environment to eliminate the victimization of immigrants and those with limited English

language proficiency; and 3) to enhance the civil and legal rights of immigrant and limited English language crime victims.

Disabled Crime Victims

The goals for persons with disabilities who are crime victims are: 1) to provide equal access to the criminal justice system and to services for persons with disabilities who are crime victims; 2) to increase the understanding of, and response to, crimes against persons with disabilities by service providers; and 3) to increase the awareness and understanding of persons with disabilities to recognize when a crime is committed against them and to access the civil and criminal justice systems to obtain redress.

Visitor Crime Victims

The goals for visitor crime victims are: 1) to provide temporary assistance to address the immediate needs of visitors who are victims of a crime; 2) to reduce the incidence of crimes against visitors by increasing the awareness of safety and security issues and increasing enforcement against perpetrators of crimes against visitors; and 3) to reduce bureaucratic obstacles to access to services for visitors who are the victims of crime in Hawaii.

The Commission, the Victim Witness Kokua Services Division of the Honolulu Department of the Prosecuting Attorney ("Victim Witness"), and the Visitor Aloha Society of Hawaii - Oahu ("VASH") are working together to ensure that visitor crime victims have timely access to compensation to cover their crime-related expenses. VASH and Victim Witness help visitor crime victims apply for compensation before they return home, and they obtain necessary medical authorizations from the visitor that the Commission needs to process compensation claims. The Commission, VASH, and Victim Witness work together to expedite claims when victims have an immediate need for assistance and/or compensation. VASH and Victim Witness representatives are available to assist visitor crime victims twenty-four hours a day, seven days a week.

The Commission and the Visitor Victims of Crime Subcommittee are working with the Hawaii Criminal Justice Data Center to address crimes against visitors involving the theft of personal identification. Every day across Hawaii a number of visitors have their personal identification stolen. Without personal identification, the visitor may not be able to continue on with their vacation plans because it is difficult for them to rent a car, visit a federal monument, buy an alcoholic drink, or be cleared by airport security to return home. Subcommittee members are working on strategies to expedite the replacement of personal identification documents.

The Commission and all of the Subcommittee members are committed to achieving the goals articulated in the Strategic Plan.



Assessment and Collection of the Crime Victim Compensation Fee

In 1998, the Legislature created the crime victim compensation fee (the "Compensation Fee") to provide a funding base for the Commission to become fiscally self-sufficient. The Commission no longer receives any State general funds. The Compensation Fee is mandatory and must be assessed against every offender who is convicted of, or who enters a deferred plea (DAG/DANC) to, a petty misdemeanor, misdemeanor, or felony, and is able to pay the fee.³

Since the Compensation Fee was enacted, the Judiciary has neglected to order and collect Compensation Fees, as provided for in the statute, in an amount exceeding one million dollars, described above as the Revenue Collection Shortfall. In the first year that the Fee was mandated (FY 1999), the Judiciary assessed and collected less than half of the fee revenue that was anticipated. While the Judiciary estimated Compensation Fee revenue of \$844,913.00 for FY 1999, less than \$300,000.00 was actually collected. In FY 2001, the Judiciary estimated fee revenue at \$969,131.25 while only \$650,562.75 was collected, and in FY 2002, the Judiciary estimated fee revenue at \$778,262.00 while only \$649,005.48 was collected.

The Commission received \$763,424.80 in Fee revenue from the Judiciary in FY 2003, \$817,075.41 in FY 2004, and \$818,929.02 in FY 2005.


Act 144 of 2005 increased the Compensation Fee was increased by five (5) dollars in each category.

³ Section 351-62.6, Hawaii Revised Statutes, provides that the court shall assess a Compensation Fee against every convicted offender, or offender who enters a deferred plea, and who is or will be able to pay the Fee. Fees are assessed as follows:

^{1.} a \$25 fee for a petty misdemeanor;

^{2.} a \$50 fee for a misdemeanor; and

^{3.} a \$100 to \$500 fee for a felony.

Dedicating resources to court monitoring is necessary to ensure that there is sufficient funding to provide adequate compensation to violent crime victims in Hawaii, and to ensure the continuing fiscal self-sufficiency of the Commission.



Conclusion

For the past 37 years, the Commission has provided increasing levels of service every year to the victims of violent crime. The Commission has streamlined case processing by increasing management efficiency,

reducing case backlog, cultivating strategic partnerships with other public and private agencies, and making significant progress towards fiscal self-sufficiency. Even with all of these improvements, the Commission continues to pursue strategies to further improve services to crime victims.

The Commission will continue to diligently pursue its mission to mitigate the costly and emotionally devastating impact of violent crime on citizens and visitors through continued collaborative efforts, further improvements in management efficiency, and strong staff commitment.


