PAROLE GRADUATION MARKS PERSONAL SUCCESSES ON THE PATH TO REINTEGRATION

Public Safety Director Sakai among five honored for support of parolees

HONOLULU – The Annual Parole Completion Celebration was held Thursday night at Hawaii State Supreme Court Aliiolani Hale to honor individuals who completed parole as well as those who helped them. The event was put on by the Hawaii Friends of Justice and Civic Education Organization, a non-governmental organization dedicated to improving the justice system.

Parole completion ceremonies have been held four times in the past three years, involving more than 200 people including judges, parole board members, lawyers, prison staff, counselors, formerly incarcerated people and the parolees' loved ones.

State Public Safety Director Ted Sakai was among those honored by the Hawaii Friends of Justice and Civic Education organization for their support of parolees successfully working their way through the parole and reintegration process. Director Sakai was given the Restorative Prison Award, which was renamed the Ted Sakai Restorative Prison Award in his honor. Director Sakai introduced restorative justice at Waiawa Prison in 2003, when he was the warden.

"When people think of the criminal justice system, the first thing that comes to mind is conviction and incarceration of law violators," said Director Sakai. "Restoration is a crucial part of the criminal justice process. It focuses on positive behavior and is proven to promote healing and help parolees stay out of prison and become productive citizens again."

Restorative justice programs focus on meeting the needs of individuals and communities who have been affected by wrongdoing. They involve group discussion

sessions that give victims a voice, while offering offenders the opportunity to develop a transition plan and determine how they can best reconcile in their particular situation. Offenders can then work to repair the harm their imprisonment and/or law violations have caused their families and the community.
