On Wednesday, May 7, Gov. Neil Abercrombie and Lt. Gov. Shan S. Tsutsui proclaimed May 4-10 "Correctional Officers and Employees Week" and

May 11-17 "Police Week" in Hawaii. The two proclamations were presented by Acting Gov. Tsutsui to the Corrections and Law Enforcement Divisions.

"We commend all those who currently serve in the corrections and law enforcement profession, those who have served and those who have been lost in pursuit of these most honorable professions," Acting Gov. Tsutsui said.

In 1984, President Ronald Reagan designated May 4-10 as National Correctional Officers and Employees Week under Proclamation 5187. It is designed to provide correctional employees the respect and recognition they deserve.

In 1962, President Kennedy proclaimed May 15 as National Peace Officers Memorial Day and the calendar week in which May 15 falls as National Police Week.

National Police Week pays special recognition to those law enforcement officers who have lost their lives in the line of duty for the safety and protection of others as well as the family members, friends and fellow officers they left behind.

#### **Sheriff Deputy Completes FBI National Academy**

I was honored to have been selected to attend the 256th Session of FBI National Academy. Classes consist of approximately 225 officers. Participation is by invitation only, through nomination and a strict screening process conducted by the FBI. Participants are drawn from every state in the union, from U.S. territories, and from over 160 international partner nations.

Various courses of study are offered in areas such as law, behavioral science, forensic science, leadership development, communications, and health/fitness. Officers participate in a wide range of leadership and specialized training, and they share ideas, techniques, and experiences with each other, creating lifelong partnerships that span state and national lines.

I took advantage of my time there to self-evaluate and learn from some of this nation's best instructors and police executives. I was able to forge a network of subject matter experts and friends from across the United States and 33 foreign countries. I was humbled to attend after-hour leadership seminars by some of the most inspirational speakers I have ever heard.

I was cold (temperatures ranged from 5 degrees to 40 degrees) and I missed home but the opportunity to learn from my classmates and the instructors was truly worth the challenges.

Being almost 50 years old and far beyond my school days, it was intimidating to be required to write multiple ten to twenty page term papers in American Psychological Association (APA) format. My papers included the Psychopathy and Sociopathy of Violent Offenders in Hawaii, Law Enforcement Executive Leadership, Philosophy of Leadership, and Psychosocial Behavior and Intelligence Trends.

Physical fitness is stressed heavily during the training and each section meets three days per week to learn and apply physical conditioning training for two hours per session. Each fitness instructor is a fully credentialed trainer and most were former strength and conditioning coaches for professional sport teams in the MLB or the NFL.

As an extra, each Wednesday the entire class would come together for a "Wizard of Oz" themed challenge that started with a two mile run on week one called, "You Aren't In Kansas Anymore" and ended with the 6 mile endurance challenge called the "Yellow Brick Road". In addition, I participated in the Blue Brick Challenge which consisted of a 34 mile swim which needed to be completed in less than 9 weeks. The challenge symbolized swimming from Quantico to D.C. via the Potomac River.

As a class we were required to participate in field trips to venues such as the National Law Enforcement Memorial (see picture) and the Holocaust Museum. At the museum, we were treated to a personalized guided group tour and later participated in a short seminar which asked, "What could Law Enforcement have done to prevent Nazi Germany." The tour was terribly sad and moving but the museum was incredible.

One of the most valuable lessons I learned while attending the academy is that my professional and personal life will never be the same. The National Academy will guide me in my future decisions and my conduct for the remainder of my life. As a graduate of the NA, the law enforcement community expects more from you and demands that you conduct your daily activities with a healthy dose of honor and respect. That honor reflects the pride in your agency and your association with the National Academy.

#### **Sheriffs Help Reunite Twin Boys**

This case originated in Cook County, Illinois and involves twin boys who are 3 1/2 years old.

On Friday, April 11, 2014, the Sheriff's Airport Section received a call about a Custodial Interference case where the estranged mother of the sons had taken one of the boys to Japan. Information was received that the mother and son would be flying through Honolulu.

After working on this case for several days, Sergeant Collin Malani and Deputy Sheriffs James Lupo and Brian Brunn met up with Jerry Canada, the father of the twins and went over the documents.

On Tuesday, April 14, 2014, Deputy Lupo was able to reunite the twin boys and their father at Honolulu International Airport. It was an emotional situation as the mother became visibly upset, yet the twin boys were overjoyed to finally be reunited.

The following email and photo was sent to Lt. Oakland:

Dear Sgt. Malani, Lt. Cmd. Oakland, Deputy Lupo, and Team:

I want to thank each of you for your help in reuniting my son Kanoa with his identical twin brother Manato after 568 days of being separated. I realize there is a very painful human element in doing what you do. I know you are all professionals however, I'm sure there is little joy in the way this had to come about. Please know that I had tried everything within reason long before involving the law, with a person that separated brothers, leaving her other child with underlying health conditions behind. I have attached a picture of Kanoa and Manato from their flight back to the mainland.

You have my deepest gratitude.

### Deputy Douglas Takayama - Going Above and Beyond

This is a story about the actions of Deputy Douglas Takayama, who on March 26th at around 7 p.m., was sent to a report of a woman driving erratically in the Inter-island parking structure.

Security had reported that a woman was "driving erratically." Upon his arrival, he observed a female in her vehicle who appeared to be very emotional. She was crying and constantly wiping tears from her eyes.

Numerous security personnel in the area reported

that she had struck many of the yellow-colored, plastic pylons that separated the entry lanes to the parking structure.

Deputy Takayama approached the woman and asked her if she needed medical attention, and if she was okay. She stated that she had forgotten to take her medication. Takayama asked what she needed and she started crying hysterically, and stated, "I want to kill myself."

Takayama reacted by performing in a very professional, caring manner, and was able to get her to come out of her vehicle. Prior to talking to Takayama, the woman did not appear to have any intention of exiting her vehicle. Takayama created such a good rapport with her, that he was able to get her to come out of the vehicle without incident.

Takayama kept telling her that he would not leave her, and he was there to help her.

The incident turned out to be something totally different than what had been reported by security. Takayama responded appropriately as the circumstances changed. He per-


