The Hawaii Department of Public Safety is planning to replace the Oahu Community Correctional Center and is seeking building sites for consideration.

Site Features	Requirements
Land Area	Minimum of 10 acres of developable land; preferably 15+ acres
Preferred Search Areas	Greater Honolulu and the East and West Oahu areas
Site Conditions	Minimal development/environmental constraints (e.g., topography, soils, wetlands, floodplains, wildlife habitats, historic sites)
Past/Present Land Uses	Absent current or past land uses that could pose risk of contamination
Water Supply Service	Reasonable access to publicly owned/operated water supply system
Wastewater Treatment Service	Reasonable access to a publicly owned/operated wastewater treatment works
Electric Power Service	Ability to access a primary electric transmission line
Natural Gas and Tele- Communications Services	To be determined based on institution needs and availability
Access	Direct (nearby) access to federal, state, or county designated roadways

#### SITE OFFER FORM

The Hawaii Department of Public Safety (PSD) is evaluating options for the replacement of the Oahu Community Correctional Center (OCCC), which has been in operation since 1975 and today is the largest jail facility in the state of Hawaii. Given its age, OCCC is in need of immediate replacement. The state-of-the-art in jail design has advanced considerably since 1975 when OCCC was conceived and constructed and a new OCCC would better meet the current and future needs of the state of Hawaii, while ensuring the safety of inmates, correctional staff, and the public-at-large.

To assist with the planning for replacement of the facility, PSD is seeking information and offers from the real estate industry, state and local planning officials, property owners, and the public concerning potential sites capable of being developed with a new OCCC. PSD will carefully and deliberately consider, study, and evaluate all potential sites offered to it including replacing the OCCC at its current location. Below are selected criteria that should be considered in offering prospective sites.

#### PREFERRED SITE/PROPERTY REQUIREMENTS:

- Minimum of 10 acres of developable land; preferably 15 acres or more
- Minimal development and environmental constraints (e.g., wetlands, floodplains, and steep topography)
- Absent current or past land uses that could pose a risk of contamination
- Reasonable access to public water supply, wastewater collection, electric power and telecommunications services
- Access to network of federal, state and local roadways
- Compatible with adjoining and nearby land uses (avoidance of residential neighborhoods)
