### DEPARTMENT OF PUBLIC SAFETY COVID-19 UPDATE

HONOLULU – Effective April 1, 2022, the Department of Public Safety switched to weekly reporting of COVID stats. The data is updated on PSD's dedicated COVID-19 webpage every Wednesday.

COVID-19 testing is continuously being conducted in the state prisons and jails as well as in the contracted Saguaro Correctional Center in Eloy, AZ. The latest testing updates from the correctional facilities for the 5/25/22 – 5/31/22 time period, are as follows:

**Kauai Community Correctional Center** – 95 inmate test results; 22 positive, 73 negative. One (1) inmate has recovered. Three (3) positive staff test results and one (1) staff recovery was reported.

**Oahu Community Correctional Center** – 181 inmate test results; 26 positive, 155 negative. There were seven (7) positive staff test results reported and one (1) staff recovery.

**Hawaii Community Correctional Center** – 41 inmate test results; 5 positive, 36 negative. There were three (3) staff recoveries.

**Kulani Correctional Facility** – 16 inmate test results; 5 positive, 11 negative. There was also one (1) positive staff test result and two (2) staff recoveries reported.

**Women's Community Correctional Center** – 21 inmate test results; One (1) positive, 20 negative.

**Maui Community Correctional Center** – 37 staff test results; One (1) positive, 36 negative. One (1) employee has recovered. Seven (7) negative inmate test results and one (1) inmate recovery reported. The inmate population is clear of all active COVID-19 cases.

**Halawa Correctional Facility** – One (1) positive staff test result was reported and one (1) staff recovery. 43 negative inmate test results.

**Waiawa Correctional Facility** – One (1) positive staff test result and 30 negative inmate test results.

COVID-19 updates for other PSD Divisions are as follows:

**Sheriff Division** – Seven (7) new positive staff test result were reported during this time. Eight (8) employees have recovered and returned to duty.

**Administration Division** – Four (4) positive staff test results and six (6) recoveries were reported during this time period.

The Department of Public Safety (PSD) continues to encourage all staff and inmates to voluntarily get tested and receive the COVID-19 vaccination.
