### DEPARTMENT OF PUBLIC SAFETY COVID-19 UPDATE

HONOLULU – Effective April 1, 2022, the Department of Public Safety switched to weekly reporting of COVID stats. The data is updated on PSD's dedicated COVID-19 webpage every Wednesday.

COVID-19 testing is continuously being conducted in the state prisons and jails as well as in the contracted Saguaro Correctional Center in Eloy, AZ. The latest testing updates from the correctional facilities for the 6/8/22 – 6/14/22 time period, are as follows:

**Oahu Community Correctional Center** – 426 inmate test results; Nine (9) positive, 417 negative. 27 inmates have recovered. There were five (5) positive staff test results reported and six (6) staff recoveries.

**Waiawa Correctional Facility** – 93 inmate test results; Six (6) positive, 87 negative. There was one (1) positive staff test result reported.

**Hawaii Community Correctional Center** – 72 inmate test results; Three (3) positive, 69 negative. Five (5) inmates and two (2) staff have recovered.

**Maui Community Correctional Center** – 305 inmate test results; One (1) positive, 304 negative. 12 staff test results; Two (2) positive, one (1) negative.

**Kulani Correctional Facility** – One (1) positive **staff** test result. One (1) negative inmate test result and six (6) inmate recoveries reported.

**Kauai Community Correctional Center** – 63 negative inmate test results. 13 inmates and two (2) employees have recovered. The inmate population is clear of all active COVID-19 cases.

**Halawa Correctional Facility** – 170 negative inmate test results. Three (3) staff have recovered.

**Women's Community Correctional Center** – 25 negative inmate test results.

COVID-19 updates for other PSD Divisions are as follows:

**Sheriff Division** – Two (2) positive staff test result were reported during this time. Two (2) employees have recovered and returned to duty.

**Administration Division** – Five (5) positive staff test results and five (5) recoveries were reported during this time.

The Department of Public Safety (PSD) continues to encourage all staff and inmates to voluntarily get tested and receive the COVID-19 vaccination.
