DEPARTMENT OF PUBLIC SAFETY COVID-19 UPDATE

HONOLULU – Effective April 1, 2022, the Department of Public Safety switched to weekly reporting of COVID stats. The data is updated on PSD's dedicated COVID-19 webpage every Wednesday.

COVID-19 testing is continuously being conducted in the state prisons and jails as well as in the contracted Saguaro Correctional Center in Eloy, AZ. The latest testing updates from the correctional facilities for the 7/6/22 – 7/12/22 time period, are as follows:

Oahu Community Correctional Center – 212 inmate test results; 31 positive, 181 negative. 42 inmates have recovered. There was also one (1) positive employee test result reported but that individual was medically cleared as recovered during this reporting period. Four (4) other employees have also recovered. The facility is clear of all active COVID-19 **staff** cases.

Maui Community Correctional Center – 357 inmate test results; Five (5) positive, 352 negative. 13 inmates and one (1) employee have recovered. The facility is clear of all active COVID-19 **staff** cases.

Kauai Community Correctional Center – There was one (1) positive employee test result reported but that individual was medically cleared as recovered during this reporting period. One (1) other employee has also recovered. The facility is clear of all active COVID-19 **staff** cases. 51 negative inmate test results reported.

Halawa Correctional Facility – 171 negative inmate test results. There was also one (1) positive staff test result reported but that individual was medically cleared as recovered during this reporting period. The facility is clear of all active COVID-19 **staff** cases.

Waiawa Correctional Facility – 94 negative inmate test results. Three (3) staff have recovered. The facility is clear of all active COVID-19 **staff** cases.

Hawaii Community Correctional Center – 78 negative inmate test results.

Women's Community Correctional Center – 46 negative inmate test results.

Kulani Correctional Facility – 17 negative inmate test results.

COVID-19 updates for other PSD Divisions are as follows:

Administration Division – Three (3) positive staff test results and one (1) staff recovery was reported during this time.

Sheriff Division – One (1) employee have recovered and returned to duty. The Sheriff Division is clear of all active COVID-19 cases.

The Department of Public Safety (PSD) continues to encourage all staff and inmates to voluntarily get tested and receive the COVID-19 vaccination.
