

## WCF Inmate VISIT COVID Protocols

Below protocols are in addition to the current established Visitation Rules posted  
on the PSD website and House Rules  
Effective March

**If COVID restrictions rise/quarantines or staff availability to run visits they will be canceled  
Please call (808) 677-6157 after 6am the day of visits to ensure it is running.**

### General COVID Rules

1. All staff, inmates and persons going to/from and entering the prison and visit area, **will always wear barrier masks for full duration and going to/from and while at the visit.** Inmates have all been issued by WCF barrier masks.
2. You are reminded to follow and comply with COR.10.1B.01 Infection Control Program and COR.13.03-5.5a 9(9) Failure to follow sanitary rules.
3. Staff, inmates, visitors shall report any fever, cough, and shortness of breath immediately to the staff member on duty & Health Care Unit (HCU).
4. **Spacing is limited and Visits are on a first come, first served basis.**
5. **COVID Testing at Check-In (voluntary):**
  - a. **Visitors that complete the COVID testing (voluntary) and have negative results;**
    - i. Will be allowed to sit at the same table as the inmate.
    - ii. See the current COVID posted signs for restrictions.
    - iii. Please show up at check-in time to allow testing.
  - b. **Visitors that do not wish to get tested;**
    - i. Will be seated separate from the inmate in a chair 6 feet away from the table.
    - ii. There is to be always a 6-foot distance between you and any inmate.
    - iii. In case of a public citizens(s), visitor tries to approach the inmate **to breach the 6 foot barrier**, inmates are instructed to walk away and alert the supervisor or staff immediately and distance themselves. If the public or person breaches a 6-foot barrier, the inmate(s) will report to the ACO immediately and wait for further instructions.
6. Tables, chairs & equipment are sanitized before and end of each visit with disinfectant already in use at the facility.
7. Inmates will only sit in designated areas, assigned by staff, separated by housing units.
8. Follow ALL posted COVID signs.

### Restroom


1. All inmates are currently advised that bathrooms are limited during this pandemic and to use the bathrooms **prior** to leaving their housing unit.
2. If a visitor, during the visit, needs to use the restroom they will leave the visit area to use the bathroom in Education. They will not be allowed back for the remainder of the visit. Visitors may use before and/or after the visit.
3. Inmate may be sent, by Security, back to the housing unit to use the bathroom and the visit would be canceled at that time.

Continue to keep COVID-19 out of our Facility. Help keep our inmates and staff safe.
