## 1.0 PURPOSE

The purpose of this policy is to identify the individual with the overall responsibility for the administration, management, and supervision of health care services at each facility.

## 2.0 SCOPE

This policy and procedure shall apply to all correctional facilities and their assigned staff within the Department of Corrections and Rehabilitation (DCR).

### .2 Definitions

- a. Chief Physician: The Physician II responsible for supervision of medical services and medical care. The Physician II is the facility Medical Authority.
- b. Clinical Section Administrator (CSA): The Registered Professional Nurse IV or V is the Health Authority and is in charge of clinical services at each facility.

## 4.0 POLICY

- .1 The Clinical Section Administrator is the Health Authority and shall be responsible for the administration, management, and overall supervision of health care services at the facility.

- .2 The Health Authority's responsibilities are documented in a written agreement, contract, or position description.
- .3 The Health Authority's position location shall be at the facility's Health Care Section.
- .4 Medical judgments and decisions rest with a single, designated, licensed, responsible physician.


**5.0 PROCEDURES**

- .1 The Health Authority arranges for all levels of health care and assures quality accessible and timely health services for patients.
- .2 In facilities with no permanently assigned physician, the visiting physician, the Medical Director, or the physician-on-call shall be the medical authority.
- .3 The Health Authority shall work with other Section and Branch Administrators to ensure smooth integration of health care services into facility operations and shall represent Clinical Services at facility administrative meetings.
- .4 Other authorities in the Health Care Sections are:
  - a. Health Information Authority: The Health Information Branch or Section Administrator or the highest-ranking Medical Record Technician shall be the authority over inmate medical records and health information management at the facilities.
  - b. Mental Health Authority: The highest-ranking Psychiatrist shall be the Mental Health Authority at the facilities. If there is no psychiatrist, the highest-ranking clinical psychologist shall be the Mental Health Authority.
  - c. Dental Authority: The dentist shall be the Dental Authority.
  - d. In facilities with no assigned Psychiatrist, psychologist or dentist, the Medical Director shall be the Mental Health and Dental Authority for the facility.


