# 1.0 PURPOSE

To ensure that there is no interference with the delivery of necessary health care to inmates with serious medical, mental, and dental needs.

# 2.0 SCOPE

This policy and procedure shall apply to all correctional facilities and their assigned personnel within the Department of Corrections and Rehabilitation (DCR).

### .2 Definitions

- a. Health Care Staff: Includes all qualified health care providers, clinicians, administrators, technicians, nursing staff, support and clerical staff, contracted service workers and volunteers.
- b. Health Care Providers: Medical and psychiatric physicians, dentists, and clinical psychologists.
- c. Clinician: A nurse, nurse practitioner, or psychiatric social worker in close consultation with the psychiatrist, psychologist, or medical doctor.

### 4.0 POLICY

.1 Decisions and actions regarding medical, mental disorders and dental care provided to inmates to meet their serious medical needs are the sole responsibility of qualified health care professionals.

- .2 Providers and clinicians shall be solely responsible for determining how they can accomplish their duties and responsibilities according to professional standards while cognizant of security procedures.
- .3 Clinical decisions and implementations are completed in an effective and safe manner and supported by the Department.
- .4 Correctional employees shall not interfere in medical orders issued by qualified providers and clinicians.
- .5 Health Staff are subject to the same security regulations as other correctional employees.
